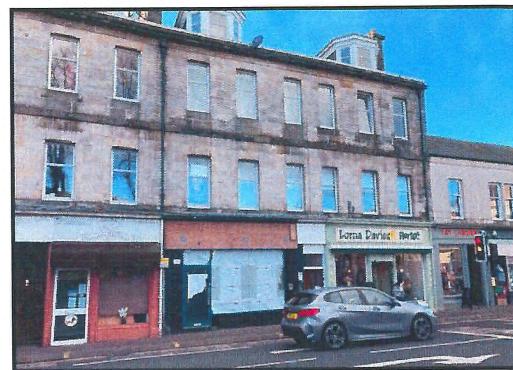

**Location**

Perth, population circa 45,000 persons is situated approximately 22 miles west of Dundee, 43 miles north of Edinburgh and 61 miles north of Glasgow. The City has excellent road and rail connections.

The unit occupies a prominent position on the west side of South Methven Street close to the High Street junction. Traders in the immediate vicinity include Johnsons Cleaners, Salmoni Opticians and Ladbrokes. The Bank Bar and Ego Nightclub are opposite and Playhouse Imax Cinema and the bus station are nearby on Murray Street. Other retailers nearby include Sainsbury and Savers,

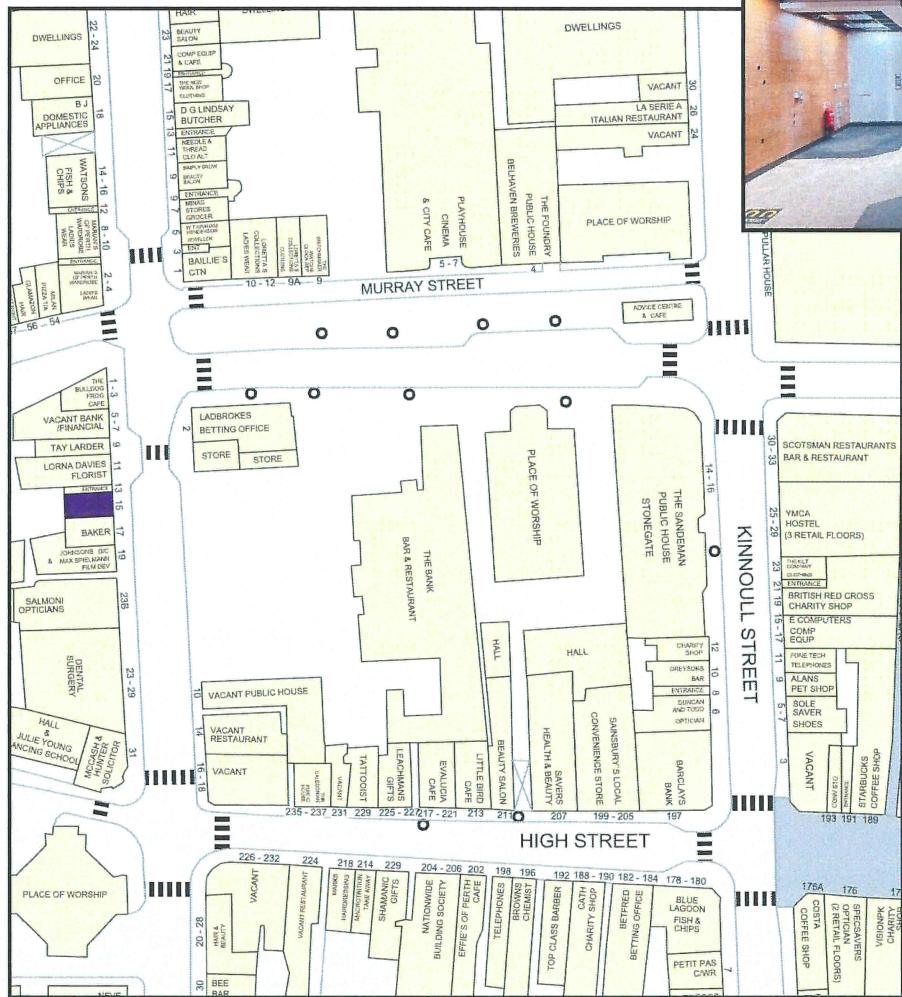
